# Maynilad warns of service interruptions

Metro crisis worsens as Angat water level continues to dip

Maynilad Water Services Inc. yesterday warned of "rotational service interruptions throughout its concession area" once regulators reduced supply when water level at Angat Dam went down to the critical low of 160 meters above sea level (masl).

According to monitoring by the Philippine Atmospheric, Geophysical and Astronomical Services Administration, the stock at Angat was at 161.78 masl at 6 a.m. of June 18, down by 0.61 meter from 162.33 masl a day before.

The National Water Resources Board (NWRB) forecast that Angat level would be at 160 masl by this weekend.

"The NWRB announced that it will reduce allocation for the Metropolitan Waterworks and Sewerage System (MWSS) once water level in Angat Dam dips to 160 meters," Maynilad said in a statement,

NWRB executive director Sevillo David said on Monday that allocation of raw water to MWSS—which is in turn treated by Maynilad and Manila Water Co. Inc. to produce potable water—had been reduced to 46 cubic meters per second from 48 cu. m effective June 1 on account of the continuous reduction of Angat's stock.

"At an allocation below 46 (cu. m), Maynilad will be constrained to implement rotational service interruptions throughout its concession area to maximize the limited supply and ensure that all customers will have some water supply, even within a few hours daily," the company said.

The West Zone concessionaire added that it had measures in place to mitigate the impact of this reduced allocation. These include the extension of operating hours of our pumping stations, prompt repair of pipe leaks and reactivation of deep wells, among others.

"If necessary, Maynilad will send out mobile water tankers and install static water tanks for severely affected areas," the company said.

Also yesterday, Manila Water issued a service advisory that it would be implementing rotational water service interruptions for

the entire East Zone.

"Despite the rains we have been experiencing these past days, the water level at Angat and Ipo Dams continue to decline, thereby affecting water availability and our ability to refill our reservoirs. The (NWRB) will reduce allocations for the water concessionaires. Release of raw water in Angat (yesterday) will just be 38 cu. m per second instead of 48 cu. m," it said.

### 12 million customers to experience low water to no water pressure for 6 to 12 hours

As much as 12 million customers of Maynilad Water Services, Inc. (Maynilad) and Manila Water Company, Inc. (Manila Water) will experience low to no water pressure for 6 to 12 hours straight starting today as the water level in Angat Dam continues to diminish.

The decision was made after the National Water Resources Board (NWRB) further reduced the Angat Dam's water allocation to Metropolitan Waterworks and Sewerage System (MWSS).

Based on the PAGASA's monitoring as of Tuesday, the water level at Angat Dam has further declined to 161.76 meters, which is just 1.76 meters short of its 160-meter critical level for domestic water supply.

### 12 million customers.

With the country currently experiencing a monsoon break, the chance of rainfall, especially over the Angat watershed, has been lessened.

If the water level at Angat Dam falls below 160 meters by June 22 (Saturday), NWRB said another water allocation adjustment will be implemented simultaneous with the shutting down of the auxiliary unit.

The auxiliary outlet, which is being used at the moment, could no longer be utilized once the water level falls below 160 meters.

NWRB assured that it will allocate at least 36 cms to MWSS should the dam further decline to 150 meters.

But the implementation of lower water allocation could adversely affect the normal delivery of water services to Maynilad and Manila Water, the agency said.

"Expect rotational water service interruptions, which will be announced the soonest possible time," NWRB advised the public.

It appealed to the public to "conserve water and pray for heavy rains" to help elevate the dwindling water level at Angat Dam.

"We are really entering unprec-

edented levels for Angat," Manila Water President and Chief Executive Officer Ferdinand Dela Cruz said earlier.

Angat Dam had its lowest water level back in 2010, but it only went down to as low as 157 meters.

Right now, the dam releases about 4 million liters of water per day (mld). Of this, Manila Water gets an allocation of 1,600 mld, while Maynilad is allowed to get the rest or about 2,400 mld.

With allocation for MWSS reduced, low-water pressure can be expected both for Manila Water and Maynilad customers.

Company officials estimate that about 6.9 million or 70 percent of Maynilad customers will start experiencing low water pressure or rotational interruption, while as much as 5.4 million or 80 percent of Manila Water customers will suffer from the same ordeal.

"We are constrained to implement a new scheme of rotational water service interruptions for the entire East Zone for about 8 to 12 hours during night time. We will post the schedule of water interruptions in our social media platforms. We will continue to provide regular updates regarding water supply outlook for the East Zone," Jeric Sevilla, head of Manila Water's corporate communications, said.

Manila Water, which currently has 6 million customers, provides water to 23 cities and municipalities in Metro Manila and Rizal. These include Mandaluyong, Makati, Pasig, Pateros, San Juan, Taguig, Marikina, and parts of Quezon City and Manila. The towns of Angono, Baras, Binangonan, Cainta, Cardona, Jalajala, Morong, Pililia, Rodriguez, Tanay, Taytay, Teresa, San Mateo and Antipolo in the province of Rizal are also part of the East Zone.

Maynilad, on the other hand, has 9 million customers from cities of Manila (all but portions of San Andres and Sta. Ana), Quezon City (west of San Juan River, West Avenue, EDSA, Congressional, Mindanao Avenue, the northern part starting from the Districts of Holy Spirit and Batasan Hills), Makati (west of South Super Highway), Caloocan, Pasay, Parañaque, Las Pinas, Muntinlupa, Valenzuela, Navotas and Malabon, all in Metro Manila; the cities of Cavite, Bacoor and Imus, and the towns of Kawit, Noveleta and Rosario, all in the Province of Cavite.

NWRB and MWSS are now appealing to the public to conserve water and pray for heavy rains to come in the Angat watershed area."

### Interruptions set for bulk of Maynilad,

### Manila Water customers

A huge portion of Metro Manila and nearby provinces should expect service interruptions until this weekend after the National Water Resources Board (NWRB) decided to further cut allocation amid the continued drop in the water level at Angat Dam, the metro's main water source.

The NWRB is reducing the allocation for Metropolitan Waterworks and Sewerage System (MWSS) to 40 cubic meters per second (CMS) from the current 46 CMS starting today until this weekend.

The NWRB meanwhile is

fine-tuning preparation of the low-level outlet as a back-up water discharge before the Angat Dam level reaches 160 meters and lessen the significant effect of limited water supply in the coming days.

With the cut in allocation, 70 percent of the customer base of west zone concessionaire Maynilad Water Services Inc. will be affected while 80 percent of east zone Manila Water Co. Inc. will be hit.

Angat Dam's water level dropped further to 161.78 meters yesterday and is expected to hit critical level this weekend.

As of 6 a.m. yesterday, the water supply of Angat Dam,

which supplies 97 percent of Metro Manila's water demands, was 18.22 meters below its normal operating level of 180 meters.

MWSS administrator Reynaldo Velasco said Angat Dam's water level would dip to a low-level mark of 160 meters if it will not rain by June 20.

"If the (monsoon break) forecast of PAGASA continues, we would reach 154 meters by end of June," Velasco said, referring to the Philippine Atmospheric, Geophysical and Astronomical Services Administration, in an interview with radio station dzMM.

"This will affect water supply going to our treatment

plants and consequently, our ability to refill our reservoirs. We are therefore constrained to implement a new scheme of rotational water service interruptions for the entire east zone for about eight to 12 hours during nighttime," Manila Water spokeman Jeric Sevilla said.

"Of the 70 percent, 20 percent will be severely affected, where only eight hours will be the supply window. The remaining 50 percent, they have roughly nine to 16 hours of water supply," Maynilad Water Supply Operations head Ronaldo Padua said.

Maynilad said it has mitigating measures in place, including the extension of the operating hours of pumping stations and the reactivation of deep wells. It will also deploy mobile water tankers and install static water tanks for severely affected areas.

Further, NWRB executive director Sevillo David Jr. said another adjustment will be undertaken on Saturday or once the 160-meter level is breached because the auxiliary unit will be shut down.

"However, it is assured that at least 36 CMS will be allocated to MWSS until the dam further declines to 150 meters, assuming that there is no significant inflow," David added.

While there were intermit-

tent rains in the past few days, the NWRB said these have not significantly improved the water elevation in Angat Dam.

"It continuously declines despite the PAGASA pronouncement of the onset of rainy season. A monsoon break is present in the country which lessens the chance of rainfall in the coming days. Earliest downpour is expected in the last week of June," David said.

The NWRB is urging the public to conserve water to reduce the water demand from Angat Dam to prevent the rapid decline of water level and contribute to its recovery.

### Water interruption seen as Angat Dam nears critical level

ROTATIONAL interruptions in water service are expected in Metro Manila after the Angat Technical Working Group (TWG) proposed to reduce the water allocation to the Metropolitan Waterworks and Sewerage System (MWSS), with Angat Dam's level seen to breach 160 meters in the next few days.

"The TWG is proposing to reduce the allocation to MWSS from 46 CMS to 40 CMS starting June 19 to 21 to fine-tune the preparation of the low level outlet (LLO) as a back-up water discharge before the Angat dam level reaches 160 meters. This is to lessen the significant effect of limited water supply in the coming days," TWG said.

As of June 18, 6:00 a.m., the dam's water level is at 161.7 meters, which is expected to further decline despite the onset of the rainy season.

The reduction in allocation will affect 70% of customers of Maynilad Water Services, Inc. and 80% of Manila-Water customers.

In a statement, Manila Water said this development "will affect water supply going to our treatment plants and, consequently, our ability to refill our reservoirs. We are therefore constrained to implement a new scheme of rotational water service interruptions for the entire East Zone for about 8 to 12 hours during night time. We will post the schedule of water interruptions in our social media platforms. We will continue to provide regular updates regarding water supply outlook for the East Zone."

Maynilad, for its part, said, "We are constrained to implement rotational service interruptions throughout our concession area to maximize the limited supply and ensure that all customers will have some water supply, even within a few hours daily."

"Maynilad has measures in place to mitigate the impact of this reduced allocation, including the extension of operating hours of our pumping stations and reactivation of deep wells, among others. If necessary, Maynilad will send out mobile water tankers and install static water tanks for severely affected areas."

In a statement and subsequent clarification note, the National Water Resources Board said it is "constrained to implement a new scheme of rotational water service interruptions" in all of Metro Manila.

# Angat Dam level alarming— —MWSS

HE Metropolitan Waterworks and Sewerage System on Tuesday raised the alarm over the poor water supply at Angat Dam in Bulacan, saying its elevation could further dip below the critical level of 160 meters.

In a dzMM radio interview, MWSS Administrator Reynaldo Velasco said the dam's water level "a little above" the 160-meter critical nark.

He said the rain in the past week were not enough to help replenish the dam's dwindling supply.

According to Elmer Karingal, a Philippine Amospheric, Geophysical and Astronomical Services Administration's hydrologit, as of yesterday 6 a.m., the dam's waer level went down to 161.78 meters from Monday's 162.39 meters.

"We oserved the water elevation go down by 61 meters yesterday, or more than hal/a-meter," he said.

"We have projected that should there'll be no sin on June 20, the level would plunged 160 meters," Velasco said.

Kamgal, for his part, said the dam's elevatio could even dip below 160 meters.

"O July 18, 2010, Angat Dam was at its livest at 157.56 meters. In July 2014,

its elevation went down to 160 meters something. But based on our hydrograph or manual graph, despite the prevailing El Niño phenomenon during those years, Angat Dam was able to recover from its low water supply," he said.

"We are hoping rains would come on the third week of July or first week of August since typhoons are expected to enter the country and to spawn rains," he added

The enhancement of the southwest monsoon due to a typhoon could trigger downpour, he said.

Velasco fears that Angat Dam's level would reach 154 meters by end of June, saying the two water concessionaires of MWSS—the Manila Water Co. Inc. and Maynilad Water Services Inc.—might end up adopting rotational service or service interruption, and water rationing.

The two water firms advised their over 15-million customers to prepare for pos-

sible water interruptions. A rotational service interruption in the East Zone concession area would start Tuesday night, Manila Water said.

The National Water Resources Board has reduced the volume allotted to concessionaires from 46 cubic meters per second to 40 cms.

Meanwhile, grid operator National Grid Corporation of the Philippines placed the Luzon grid on red alert due to shortage of power generation capacity for three hours on Tuesday, the 11th red alert raised since January this year which resulting to rotational brownouts in selected areas.

Manila Electric Co. implemented manual load dropping or removing loads from the grid starting from 1:19 p.m. yesterday which affected areas in Calumpit, Hagonoy and Malolos in Bulacan. Meralco also implemented MLD in some areas in Metro Manila namely Caloocan, Malabon and Navotas.

Meralco put on standby participants of its interruptible load program in the wake of the supply deficiency.

"Corporations and commercial establishments participating under the ILP are ready to use their generator sets to help prevent / minimize incidents of power outage," the company said.

# Consumers hit by double whammy

CONSUMERS may have to bear more rotating brownouts and rotating water interruptions due to the limited supply of power and water in the coming weeks.

Luzon Grid was placed under red alert yesterday due to extreme insufficiency in the amount of available power reserves as peak power demand hit 11,114 megawatts (MW) against an available supply of 11,402 MW.

Water level in the Angat dam is expected to breach the 160-meter critical elevation level within the next three days.

The National Water Resources Board (NWRB) said as of 6 a.m, yesterday, Angat's level was at 161.78 meters.

It said the technical working group is proposing to reduce the allocation to the Manila Waterworks and Sewerage System (MWSS) from 46 cubic meters per second (cms) to 40 cms starting today June 19 to June 21 to fine-tune the preparation of the low-level outlet as a back-up water

discharge before the Angat dam level reaches 160 meters. This is to lessen the significant effect of limited water supply in the coming days," the agency explained in a statement.

NWRB said assuming that the 160 meter level is breached on June 22 based on the projection, another adjustment will be undertaken in the MWSS allocation because the auxiliary unit will be shut down. But it assured at least 36 cms will be allocated to MWSS until the dam further declines to 150 meters assuming that there is no significant inflow.

"This will considerably impact

"This will considerably impact the normal delivery of services of both Metro Manila concessionaires, Maynilad and Manila Water and the Bulacan concessionaire. Expect rotational water service interruptions which will be announced the soonest possible time," the agency said.

Manila Water said the reduction will affect its water supply going to its treatment plants and

Meanwhile, the National Grid Corporation of the Philippines (NGCP) said yesterday's power situation resulted to a total of 32 yellow alerts and 11 red alerts since the power supply deficiency was experienced in the Luzon Grid way back from March.

NGCP said the scenario caused power interruptions for customers of Cagayan Electric Cooperative, Pampanga Electric Cooperative, Quezon Electric Cooperative, Camarines Sur Electric Cooperative and the Manila Electric Co. (Meralco).

Meralco said its customers from the municipalities of Hagonoy, Calumpit and Malolos in Bulacan were affected as well as some parts of Caloocan, Malabon and Navotas.

A total of 231.38 MW of capacity from 116 participants of the interruptible load program ran their own generator sets in order to decrease the demand from the grid.

The Department of Energy said that the power supply deficiency yesterday was caused by the unplanned outages of four coal power plants with a total capacity of 765 MW as well as the de-rated capacity of six power plants, mostly hydro plants caused by the low water level in dams.

METRO Manila residents will face a fresh round of water supply interruptions starting today, water concessionaires Maynilad and Manila Water said.

The announcements were made yesterday afternoon, shortly after the National Water Resources Board (NWRB) said they will reduce the water allocation for Metro Manila. The supply interruptions are seen to affect over 12 million homes

NWRB Executive Director Sevillo David Jr. said the allocation for Metro

Manila will be reduced to 40 cubic meters per second (cms) on June 19 to 21 from the current rate of 46 cms to prevent a drastic plunge of the water level in Angat Dam, which is Metro Manila's biggest water source. Water utility firms will have to come up with their own schedules for the rotating supply interruptions, he added.

The water level in Angat Dam further dipped to 161.78 meters as of 6 a.m. of Tuesday. The agency projects the dam will breach the critical level of 160 meters this week, which would then trigger a reduction of water supplied to Metro Manila concessionaires. The dam's minimum operating level or the rate it can comfortably

cover the region's needs - is at 180 meters.

However, another adjustment will be made to the amount of water released from the reservoir should the dam breach its critical level. By June 22, the allocation may drop to 36 cms until the dam's water level slips further to 150 meters. "This will considerably impact the normal delivery of services of Metro Manila concessionaires Maynilad and Manila Water, and the Bulacan concessionaire. Expect rotational water service interruptions, which will be announced at the soonest time possible," David said in a press briefing.

The NWRB said the adjustment will mean a reduction of 500 million liters per day - a volume equivalent to 50,000 water trucks.

Maynilad Water Supply Operations head Ronald Padua said roughly 6.9 million homes will see reduced water supply by Wednes-day. Half of their customers in the west zone will have 10 to 16 hours of steady supply, while 20 percent will have eight hours of flowing water. Prior to this, the water firm has been implementing rotating service interruptions between 10 p.m. to 5 a.m. to manage dwindling water supply

"Pipilitin namin na off-peak lang ang reduction pero baka maramdaman na kahit peak hours o sa araw [We will try to schedule the water interruptions during off-peak times, but this may be felt even dur-ing the dayl," Padua said after their meeting with the NWRB.

Manila Water communications manager Dittie Galang said separately that 5.4 million households will have weak or no water supply for four to 17 hours starting tomorrow. This comes three months after the Ayala-led concessionaire had to implement weeklong rotating service interruptions in March, which was blamed to a huge supply deficit for Manila Water

Manila Water corporate communications head Jeric Sevilla said they have "not fully recovered" from the March supply shortage, with a remaining a daily deficit of about 40 million liters. "This lowering of the levels of the Angat and Ipo dams and the possible reduction in the allocation will further aggravate our very volatile and unstable water supply situation," he told CNN Philippines' New Day.

To date, only about 90 percent of Manila Water's clients have round-the-clock supply, while 99 percent are assured of at least eight hours of flowing water per day, Sevilla said. Manila Water has advised customers about a fresh round of supply interruptions last Sunday.

The National Water Resources Board (NWRB) is set to further reduce the allocation for domestic water supply starting today, as Metro Manila's main water source, the Angat Dam, is now almost at its critical level.

In a meeting yesterday with the technical working group composed of the Metropolitan Waterworks and Sewerage System (MWSS), National Irrigation Administration, National Power Corporation, Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), and water concessionaires Manila Water and Maynilad, NWRB has proposed to reduce the water allocation to MWSS from 46 cubic

meters per second (cms) to 40 cms starting between June 19 and 21.

This is to fine-tune the utilization of the Angat Dam's low level outlet as a back-up water discharge before the water reservoir reaches the 160-meter critical level by the end of the week.

# Puerto reminded of worsening landfill

Velasco added that while the environmental permit given to the city government could not expire, there should be no complaints against the landfill from local residents

### **By Andrio Atienza**

The Environmental Management Bureau (EMB) of the Department of Environment and Natural Resources (DENR) is urging the Puerto Princesa City government to act on the worsening situation of its sanitary landfill in Barangay Sta. Lourdes.

Edna Velasco, officer-in-charge of Palawan-EMB, said they have been reminding the officials of the city government about the unwanted condition of the sanitary landfill where tons of garbage collected daily are dumped into.

"The city government must be doing a better job in the maintenance of the landfill because the result of water testing could not pass in the standard of the DENR," Velasco said.

Velasco added that while the environmental permit given to the city government could not expire, there should be no complaints against the landfill from local residents. According to Velasco, a complaint against Barangay Sta. Lourdes sanitary landfill was already filed before the Pollution Adjudication Board of the EMB for resolution.

"Penalty will not be necessary if they will follow the required guidelines," Velasco said.

City administrator Arnel Pedrosa said the city government is considering another landfill as temporary solution but is inclined to have a waste-to-energy plan as an alternative to the present use of landfill.

He noted opposition by local residents in a new site being considered.

"There is a new site in Barangay Bahile but I heard that some of the residents are opposing it. Also, we are still expecting for the waste-to-energy project to push through. We consider the second option more viable and a long-term solution. While the first one will just be like the old landfill, a temporary solution," Pedrosa said.

# LGUs push for non-renewal of OceanaGold's Didipio FTA

By LOUISE MAUREEN SIMEON

The province of Nueva Vizcaya is appealing to President Duterte not to renew OceanaGold Philippines' financial and technical assistance agreement (FTAA), which expires today (Wednesday)

The renewal of the FTAA will allow OceanaGold to continue operating the Didipio gold and copper mine for another 25 years.

OceanaGold has supposedly been causing more than P20 billion in damages to Nueva Vizcaya's rice fields, watersheds, mountains and communities.

"That is just an estimate, it could be much more as the damage inflicted on the rice fields is unquantifiable. We are already having a hard time asking them to pay taxes, how much more this?" Nueva Vizcaya Governor Carlos Padilla told The

STAR yesterday. An FTAA is entered into between a contractor and the government for the largescale exploration, development and utilization of gold, copper, nickel, chromite, lead, zinc and other minerals. It is granted to foreignowned corporations seeking to operate in the Philippines.

The President has the final decision on the grant and re-newal of an FTAA upon the endorsement of the Mines and Geosciences Bureau and the Department of Environment and Natural Resources.

However, the DENR and MGB are pushing for the renewal of OceanaGold's FTAA, The STAR learned.

MGB assistant director Danilo Uykieng and Environment Undersecretary Jonas Leones confirmed they endorsed OceanaGold's renewal application to the Office of the President.

Department of Environ-

ment and Natural Resources Undersecretary Analiza Teh, on the other hand, said the FTAA has yet to be approved and signed by President

Padilla argued that the 300 workers in the mine site were nothing compared to the thousands of farmers being affected.

"Which one will we sacrifice? Plus, we will be pro-viding livelihood to these workers and they are better off once OceanaGold is gone. We will develop agriculture and tourism," he said.
"I refused to have a dia-

logue with them because what's the use? Any effort or initiative for a dialogue is for them to protect their interest," Padilla said

Meanwhile, environmental alliance Alyansa Tigil Mina (ATM) is also calling on Duterte to immediately rule in favor of miningaffected communities and

stop the destructive openpit mining operations of the

"The mine audit conducted by DENR in 2016 has allegedly revealed that OceanaGold not only violated several environmental laws, but also failed to comply with its contractual obligations to deliver social development to residents affected by its mining operations," ÁTM national coordinator Jaybee Garganera said.

Nueva Vizcaya is host to two of the largest mining projects in the country, OceanaGold's Didipio mine and FCF Mineral's Rurnruno Gold-Molybdenum project.

The local government and communities in the province have long been opposed to the mining industry due to the negative impacts on the people and the environment. They are pushing for more developments related to ecotourism and the agriculture sector.

# **Anti-mining groups want Duterte**

## to cancel OceanaGold's FTAA

A NTI-MINING groups have asked President Duterte to cancel the financial and/or technical assistance agreement (FTAA) of Australian-Canadian mining firm OceanaGold.

OceanaGold through its Philippine subsidiary, OceanaGold Philippines, operates the Didipio mine in the province of Nueva Vizcaya.

OceanaGold's 25-year FTAA license is set to expire after 25 years on June 20, 2019.

"Oceanagold's destructive big mining has been barricaded by indigenous communities, recently opposed in a unanimous provincial council resolution, and is even currently investigated by nine United Nations special rapporteurs. It is high time for the Duterte government to cancel OceanaGold's FTAA license and compel the destructive mine to answer for its various rights violations," said Leon Dulce, national coordinator of Kalikasan People's Network for the Environment, one of the national support groups for the Nueva Vizcaya-wide campaign against the foreign mining company.

Representatives from various Nueva Vizcaya-based people's organizations, Kalikasan PNE, Alyansa Tigil Mina, and the Greenthumb Coalition, together with Nueva Vizcaya Gov. Carlos Padilla and CBCP NASSA Secretary Fr. Edwin Gariguez raised the call for OceanaGold's FTAA cancellation before Environment Secretary Roy Cimatu in a dialogue at the DENR Central Office.

"We believe that more than a decade of human-rights violations and other negative impacts against communities and ecosystems in Nueva Vizcaya are a strong basis for denying the mining company's extension," Dulce said. Kalikasan-PNE said in 2007, Oxfam Australia

came out with a Mining Ombudsman Report narrating how villagers accused OceanaGold of engaging in "harassment and the use of strongarm tactics to pressure them to accept its plans to develop a large gold and copper mine."

"In 2011, the Commission on Human Rights found OceanaGold complicit in the forced evictions of indigenous and peasant families that included the indiscriminate burning of homes from 2008 to 2009," Kalikasan-PNE added.

Meanwhile, a 2014 environmentalinvestigation mission (EIM) ledby independent scientist group Agham found damage to forests, air pollution from dusty roads and stockpiles, and massive water pollution, all affecting the health and livelihood of affected residents. In 2017, former Environment Secretary Gina Lopez ordered the suspension of Oceana-Gold's operations, but the order was stayed by the Office of the President after the company made an appeal. In the same month, at least 133 families were forced to evacuate their homes and local community leaders experienced threats and intimidation, after military combat operations swooped across the mine's operational and expansion areas.

"To date, villagers in Oceana-Gold's host barangay of Didipio have yet to be given their due just compensation from the company. Worse, the villagers have been forced to pay with their rights and civilliberties for being vocal in demanding accountability," Dulce said.

A communication last February by nine special rapporteurs of the UN Human Rights Council, including Special Rapporteur on Environment Prof. John Boyd and Chair-Rapporteur on Business and Human Rights Surya Deva have sought answers from the Duterte administration on the series of violations involving the Didipio mine.

On Monday, the Provincial Council of Nueva Vizcaya came out with a unanimous resolution calling for the non-extension of OceanaGold's FTAA.

"We will exercise constant vigilance to make sure the Department of Environment and Natural Resources and the Duterte administration revoke the pro-plunder, pro-polluter FTAA license of OceanaGold. Its license's expiry will mark the start, not the end, of our watch," Dulce ended.

# BPI FOUNDATION TO REFOREST 100 HECTARES OF DENUDED WATERSHED IN BANGSAMORO

N pursuit of inclusive development in provinces, BPI Foundation, in partnership with Hineleban Foundation, has committed to rehabilitate 100 hectares of denuded watershed in the Bangsamoro region of Amai Manabilang, Lanao del Sur, and provide livelihood to 20 families in Barangay Pagunayan.

Maricris San Diego, BPI Foundation executive director, said that this is part of the foundation's Mindanao rainforestation and transformational business project.

"We see this partnership will significantly help restore the ecosystem and consequently bring more rain to increase agricultural production. This initiative will provide food security in the area and sustainable, disposable income for 20 families in the identified project site," San Diego said.

The project brings back the flora and fauna in the mountain range in Amai Manabilang, which is inhabited by settlers of different origins and other smaller ethnic groups.

The main source of livelihood in the area is farming, mainly crop production. The municipality is one of the largest corn producers in the province. The major crops planted in the area include sugarcane, corn, soba and buckwheat.

With this partnership, the foundation seeks to engage local communities to become custodians of the site by providing them sustainable livelihood opportunities and becoming their partners in ensuring the conservation of the reforested area.

Major components of the project include social preparation, family food-security cycle, sustainable disposable-income component, rainforestation, values and leadership transformation program, and community development planning.

The project began with social preparation and engagement with local leaders, as well as an orientation and assessment of the community members. a family food-security cycle, or 3,500 square meters of shared farming land for the community's consumption, was also established. Technical support and marketing efforts for the products of Hineleban Foundation were also strengthened.

This year's rainforestation will follow a natural succession process that will eventually lead to the planting of indigenous dipterocarp, oak and select commercial species. Throughout the project's implementation, meeting the needs of the community, as well as instilling stewardship of different project components, remain essential.

"It has always been our commitment to work with communities and experts in developing solutions to create a more sustainable environment for the benefit of generations to come," San Diego said.

# Holcim supports call for global water conservation

EADING cement maker Holcim Philippines participated in the celebration of the World Water Day (WWD), a global initiative advocating the importance of freshwater conservation, through various programs in its facilities across the country.

Holcim Philippines has been implementing projects to conserve water in its facilities and help improve access to this resource to its communities since 2015 as part of its sustainability commitments. These are part of its pledge to support global building materials leader Lafarge-Holcim Group in contributing to the attainment of 14 of the 17 United Nations Sustainable Development Goals, which aim to improve the lives of people worldwide.


Holcim Philippines Environment Man-

ager Stephanie Frogoso said the initiatives are designed to reduce the company's water consumption by at least 30 percent by 2030, as its sites are among the top water consumers in the areas it operates in.

'We continued to raise our efficiency in using this resource in 2018 by improving water-recycling facilities in our plants and consumption in the process lines. Our expansion project in the pipeline will also consider water-efficient operations, such as a closed-loop system to reduce water consumption," Frogoso added.

In its Bulacan plant in Norzagaray, Holcim currently utilizes an old quarry to collect rainwater for use in operations. This initiative can potentially provide 30 percent of the total water requirement of the plant. It is also part of the sustainable water management initiatives being implemented aside from other conservation programs in the plant.

Holcim sites also actively participate in regular cleanup activities, water quality monitoring, and information and education campaigns. In Misamis Oriental, the Lugait plant implemented the "Water, Sanitation and Hygiene" project for community day-care centers to improve access of children there to such facilities. A total of 263 students from Mauswagon and Masikalon Daycare centers benefited from the project. # Social enterprise brand joins global drive to cut plastic waste, save seas

I UMAN Nature, the country's social enterprise brand that manufactures genuinely natural products, has joined global efforts to save the seas from plastic pollution by opening refilling stations for its home-care products.

"Home care is one of our fastmoving lines, and customers have long been asking for refills because of the volume of usage. This refilling system came from several months of research, sourcing and prototyping because we wanted to ensure safety, traceability and adaptation-that the system is effective and the cost isn't a barrier for scaling up. We are working with design experts and social innovators to come up with a simpler and more scaled down model for refilling stations that can be implemented all over the country," Human Nature President and Cofounder Anna Meloto-Wilk said in an interview.

Human Nature home-care refilling stations are at SM City North Edsa and its flagship store in Commonwealth Avenue.

The co-founder of Human Nature said the launch of the refilling station is in response to the development of a holistic approach to the recycling program.

Through its latest project, Human Nature hopes to educate the behavior of consumers on the importance of recycling toward sustainability. "First, you have to clean the bottle to refill and dry it," she said.

"In terms of behavior, buy only what you need. You have to control your own desires. You will realize later you accumulated a lot of stuff and end up not using it. It will later land in the landfill," Meloto-Wilk pointed out.

A 2018 article from the United Nations Environment Program, "Our planet is drowning in plastic pollution," noted that 79 percent of plastics end up in the natural 1/2

environment. Of this proportion some 8 to 12 million tons of plastic waste go into oceans each year.

And so, Meloto-Wilk said, "if we continue business as usual, by 2050, there could be more plastic than fish in the sea by weight."

Before launching the initiative, Meloto-Wilk said, engineers of Human Nature conducted several tests to determine the quality of the bottles. "These are [made of] sturdy materials and I think you can reuse several times," she said.

Meanwhile, Human Nature is teaming up with environmental groups and eco-conscious brands to call for standardized refilling policies to make refilling more widely accessible, while ensuring consumer safety.

Currently, because refilling is classified under "filling," a manufacturing activity, Meloto-Wilk said, the implementing rules and regulations of Republic Act 9711, or the

Food and Drug Administration Act of 2009, make it highly challenging for the safe refilling of cosmetic products accessible and available to most Filipino consumers.

According to Meloto-Wilk, the presence of safe, appropriately regulated cosmetics and home-care refilling stations that are as accessible as water refilling stations can potentially spark a radical change in the way people and organizations consume goods and manage plastic waste.

Human Nature has also formed an alliance with environmental groups such as Save Philippine Seas, Marine Wildlife Watch of the Philippines, WWF Philippines, and several more environmental advocacy organizations and eco-conscious brands to create safe, sustainable, and accessible refilling stations to reduce plastic waste nationwide.

Nevertheless, Meloto-Wilk said, it is a huge challenge to wean people

away from using plastics. "People are so attached to plastics because they are good in protecting food and are affordable."

"But we need a way to change the use of plastic. Instead, we can use it over and over again so that we can reduce the volume of plastic that end up in our landfill," she added.

Meloto-Wilk said all Human Nature bottles can be returned to all Metro Manila branches. She added Human Nature is working with a recycling facility to repurpose old bottles.

The project started on March 30. Meloto-Wilk said consumers can bring their empty, clean, and dry Human Nature home-care bottles to Human Nature SM City North Edsa The Block, or to the Human Nature Flagship Store on Commonwealth Avenue, Quezon City, and get up to P10 off for every 500 milliliter, 950 ml or 1 liter bottle refilled.

The discount varies as Human Nature charges the refill by the gram to assure that in case of human error, a consumer will just pay for any excess.

Founded in 2008 by Dylan Wilk, Anna Meloto-Wilk, and Camille Meloto, Human Nature products are made in the Philippines and free from harmful chemicals. In 2012, Human Nature was recognized by the World Economic Forum's Schwab Foundation as a Champion for Social Entrepreneurship. In 2016, Human Nature became the first Asian brand to receive a Sustainability Pioneer Award from Ecovia Intelligence (Organic Monitor), a globally recognized think tank for the organic beauty industry.

# World without waste: transformationa

This year has seen promising solutions to plastic pollution in the Philippines.

VANESSA PEPINO is a Non-Resident Fellow of the Stratbase ADR Institute. She is the author of "A Balanced Approach to Solid Waste Management: Governance and Total Stakeholder Participation," the study cited in this piece.

The last two months have been replete with small victories related to the Philippines' waste problem. After languishing in our ports for years, shipping containers of garbage - plastics, household kitchen waste, shredded electronic wastes, and contaminated trash were recently shipped back to their places of origin. Whether it was low business costs, ineffective checks, or regulatory oversight that led these piles of garbage to our shores, using another country as a dumping ground is an utterly deplorable practice.

The reality is, it is cheaper to export trash to low- or lowmiddle income countries where recycling costs are cheaper than disposing of it at home. However, it is also a reality that low-income and lower-middle income economies, such as the Philippines, are

the least equipped when it comes to proper waste disposal, efficient collection systems, and recycling and recovery processes. It becomes an even more massive task to think of other countries' waste when we already have a problem in managing our own waste polluting our water bodies, affecting our health and biodiversity. In 2017 alone, Ocean Conservancy reports that the Philippines had 2.7 million tons of plastic waste, of which 17% of collected waste and 31% of uncollected waste leaked into the ocean. Not to mention, we bear the brunt of social, environmental, and economic consequences of waste pollution.

Be that as it may, there are local innovations or community-based projects that have the potential to contribute to a nationwide and long-term sustainable approach to waste management. In a recent publication titled Plastics and Circular Economy: Community Solutions, the United Nations Development Programme (UNDP) draws attention to the need to shift from a linear model of "take, make, use, and dispose"-which has led to our current waste problem-to a circular economy approach. The latter is a closed loop of "reduce, reuse, and recycle" even at local levels, where habits and behaviors are entrenched and contribute to the problem of plastic pollution. UNDP highlights best local practices around the world in "material engineering and product design, shifting consumer use and behavior, and developing sound approaches to waste collection and management" in Burundi, Jamaica, Gambia, Afghanistan, etc.

A common and outstanding theme in these countries is the

# The Philippines adopts he coral reef, or 'bangkota,' as theme of Expo 2020 Dubai

he Department of Trade and Industry (DTI) gave a sneak preview of the country's participation in Expo 2020 Dubai set from October 2020 to April 2021.

The Philippines has adopted "Bangkóta"—the ancient Tagalog word for coral reef—as its theme for the Expo.

The theme focuses on the country's natural resources, and how the Filipinos are like the coral reefs: they thrive in colonies throughout the world.

Expo 2020 Dubai is the latest edition of the World Expo that started in London in 1851. Dubai's 428-hectare expo grounds will showcase the pavilions of 190 countries, including the Philippines.

Some 25 million tourists are expected to visit the pavilions.

The Philippine pavilion will occupy a 3,000-sqm space with a 1,300-sqm enclosed area. It will be designed by Budji+Royal Architecture+Design and curated by Marian Roces. It will feature five exhibits, an artisanal café, and Go Lokal! stores.

The Philippine exhibit will be installed permanently in New Clark City, Tarlac, after the Expo.

"Our most important goal in participating at the Expo is to present a country brand that reflects our rich history and our values as caring, compassionate and creative people," said Trade Secretary Ramon Lopez.

Although the Expo is not a trade fair, Lopez said that the government's allotted budget of less than P1 billion will be earned back through tourism, trade, services and investments, as the DTI will also organize an investment mission to maximize the opportunity.

He added that President

Duterte himself was receptive to the idea of joining the Expo because there are around 700,000 Filipinos in the United Arab Emirates.

Mr. Duterte has issued Administrative Order 17 assigning DTI to lead the Philippine Organizing Committee (POC) in Expo 2020 Dubai. The POC is also composed of the Departments of Tourism, Foreign Affairs, Budget, Labor, Science and Technology, and Information and Communications Technology.

### Mesh as primary material

DTI Assistant Secretary Rosvi Gaetos said that Expo 2020 Dubai's organizers think that the PH pavilion is "humble, honest, yet progressive."

Architect Royal Pineda of Budji+Royal Architecture+Design said his group used mesh instead of concrete as primary material to depict the Philippines truthfully, rather than compete with the affluence of the other countries.

Roces curated five main exhibits—"4,000 Years Young," "Modern Becomes Filipino," "The Muslims of the Philippines," "The Coraline People" and "Oceans Pacific"—to illustrate the country's history and culture before the arrival of the Spaniards.

The exhibits seek to change the world's mindset about the Philippines, and the Filipinos' mindset about themselves.

The POC has set March 16, 2021, as Philippine National Day to mark the 500th anniversary of Ferdinand Magellan's arrival in the country. The event aims to change the old perspective that March 16, 1521, was the day Magellan discovered the Philippines; rather it was the day the country discovered Magellan.

# Writ of kalikasan hearings on WPS reset

The Supreme Court (SC) has reset oral arguments on the petition of fishermen from Palawan and Zambales to compel the government to protect disputed areas in the West Philippine Sea where Chinese fishermen have reportedly been harvesting marine resources.

In session yesterday, the SC justices decided to move the public hearing on the writ of *kalikasan* case from June 25 to

July 2.

Insiders revealed that the magistrates moved the oral arguments to a later date to allow longer preparation by petitioners and respondents.

The petition filed by the group led by Monico Abogado through the Integrated Bar of the Philippines sought the issuance of writ of continuing mandamus to protect, preserve and rehabilitate the environment in Scarborough or Panatag Shoal, Ayungin Shoal and Mischief or Panganiban Reef.

Last May 3, the court ordered the government to answer the petition filed last April 16.

Petitioners sought relief from the SC against what they called "neglect of performance of the duties of the government in violation of environmental laws resulting in environmental destruction of damage in the shoals."

They specifically accused respondents – Department of Environment and Natural Resources, Department of

Agriculture, Philippine Navy, Philippine Coast Guard, Philippine National Police and Department of Justice – of "failure to perform their duties as mandated in the abovementioned environmental laws and regulations."

They said the government specifically failed to act on activities of Chinese fishermen in those areas, which violate the country's environmental laws

Petitioners also cited the island-building activities in

Panganiban Reef as found by the Permanent Court of Arbitration (PCA) in its 2016 ruling.

The group explained that Ayungin Shoal and Panganiban Reef are part of the country's exclusive economic zone (EEZ) as declared by the PCA. They said Panatag Shoal, on the other hand, is part of the EEZ under Republic Act 9522 or the Philippine Baselines Law.

Since the three areas are part of the country's EEZ, they

said these should be covered by environmental laws of the country such as the Philippine Fisheries Code.

# **US** ambassador vows to protect

# PH's international rights amid new tensions

# in the West Philippine Sea

AVAO CITY – The Philippine government can bank on the support of the United States to protect its international rights amid the tensions stemming from the issues over the disputed West Philippine Sea, US Ambassador to the Philippines Sung Kim said on Tuesday.

In a press conference at the Seda Abreeza Hotel in Davao, Kim underscored the need to protect international rights such as the freedom of navigation and the freedom of life in light of the recent maritime incident at the Recto Bank in the West Philippine Sea where a Filipino fishing boat was reportedly rammed by a Chinese fishing vessel.

The 22 fishermen aboard the sunken Gem-Ver fishing boat at the Recto Bank were rescued by a Vietnamese fishing vessel hours after they were reportedly rammed and abandoned by a Chinese fishing vessel.

Kim said the sinking should serve as a reminder that "there needs to be a responsible maritime behavior and activities that are consistent with the international law" and called on the Philippine and Chinese governments to investigate the incident and hold the responsible party accountable.

"We believe very strongly that we all should protect international rights like freedom of navigation and freedom of life. This is why the US Navy has

continued to conduct freedom of navigation operations in the South China Sea. I think it is an important reminder to all concerned including China that the US will continue to take actions to protect international rights," he said.

He said the US government would continue to work with the Armed Forces of the Philippines (AFP) and other law enforcement agencies to "build capacity," so that the agencies would be able to deal with these types of situations more effectively.

"I think it is more important to note that what we're doing in general is to work with the Philippine military and Philippine law enforcement agencies to build capacity. I am very pleased that we have such a robust partnership with AFP including the Coast Guard," he said.

Citing US Secretary of State Michael R. Pompeo, Kim vowed the US will protect the Philippines as part of its commitment under the US-Philippines Mutual Defense Treaty.

He said any armed attack "against the Philippine forces, Philippine aircraft, and Philippine public vessels will trigger our obligations under the Mutual Defense Treaty."

"It's a very important clarification of our commitments under the Mutual Defense Treaty. And I think that clarification stands on its own. We are honestly very committed to the mutual defense treaty through our alliance, which is our oldest alliance in the pacific region," Kim added.

"When you speak of speakership, you need to have an excellent interpersonal relationship with each and every member of the House and clearly with the mandate given to Congressman Romualdez, it goes to show his good relationship with the majority of the lawmakers," Defensor said.
